Make check payable to the Lafayette County Sheriffs office. Please send (2) copies each for issuance **Subpoena/Summons Served by Sheriff with more than one person at same residence - \$1.00 per additional resident.

REQUEST FOR OUT OF STATE/SUBPOENA DUCES TECUM/SUMMONS: As stated above, it is required to file a new civil case according to the Rules of MS Civil Procedure Filing Fee \$157.50.
